WSU SOM 150th ANNIVERSARY GALA

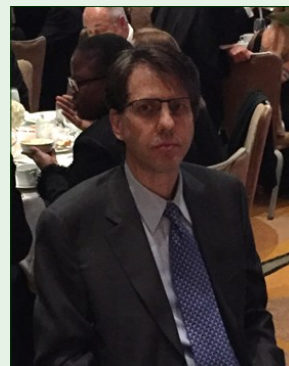

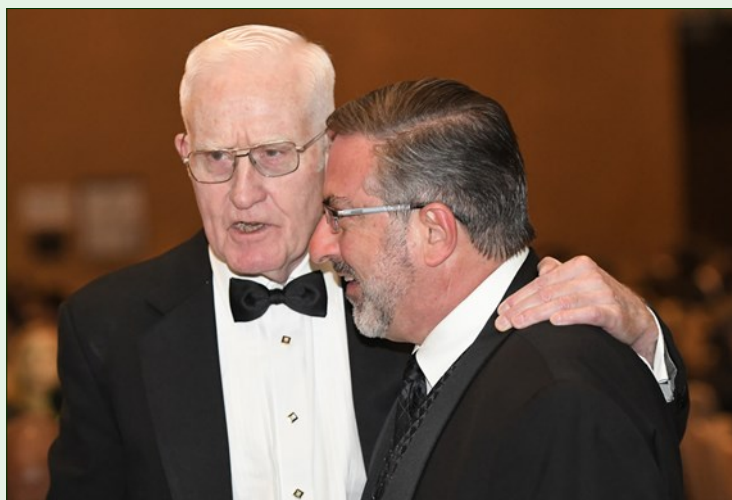

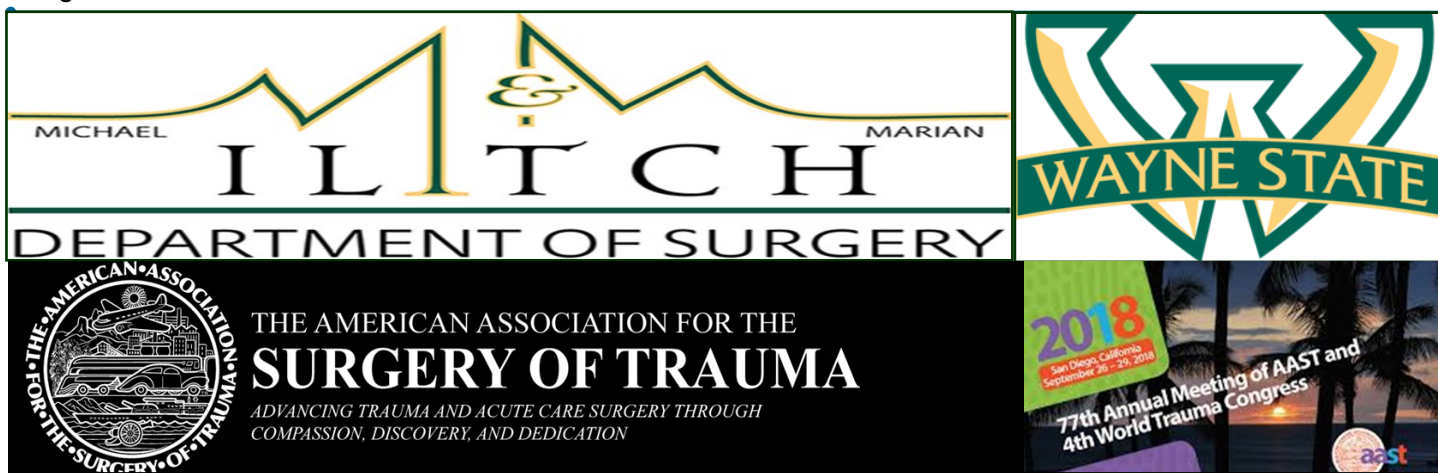

The American Association for the Surgery of Trauma (AAST) and the Clinical Congress of Acute Care Surgery had their 77th annual meeting at the Manchester Grand Hyatt in San Diego, California, the last week of September. Over the years, the WSU surgical specialists have played an important part in this very important annual meeting. This year was no exception.

Dr. Jerry Stassinopolous (WSU/GS 2004/09) was a co-author with presenters Nathan Schnockel, John Berguson, Efstothio Karamanos, Pat Patton, and Jeffery Johnson on a paper entitled "Rib Fractures in the Elderly: Physiology Trumps Anatomy." These authors demonstrated that the modified Frailty Index (mFI) and the initial blood gases, particularly the PaCO₂, outperform the RibScore in identifying the best predictor for morbidity and mortality in elderly patients.

Dr. Bryant Oliphant is a former WSU orthopedic attending and is now an attending orthopedic surgeon at the University of Michigan. He presented "ACS-COT Verification Level Affects Trauma Center Management of Pelvic Ring Injuries and Patient Mortality." Dr. Oliphant demonstrated that the mortality is about 50% greater at level 2 trauma centers compared to level 1 trauma centers and that part of this may be related to the decreased use of angiography/embolization, ORIF, ICU admission, and stepdown admission in the level 2 centers. Dr. Brian Oliphant is married to **Dr. Erin Perrone (WSUGS 2012)**, who did her pediatric surgical fellowship at Loma Linda University Children's Hospital in California and is now on the pediatric surgical faculty at the University of Michigan.

Dr. Christopher Dente (WSUGS 2002), current chief of surgery at the Grady Memorial Hospital, discussed a paper by Dr. Rishi Rattan and co-authors from the University of Miami entitled "Variation in Missed Readmissions After Appendicitis: National Analysis Including Readmission to a Different Hospital." This paper demonstrated that patients treated with nonoperative management for acute appendicitis had a higher rate of

subsequent appendectomy when admitted to a different hospital. The likelihood for subsequent appendectomy after nonoperative management was increased in those patients who left the hospital AMA, were involved with drug abuse, had diabetes, were over 65 years of age, and were admitted to a teaching hospital on the original admission.

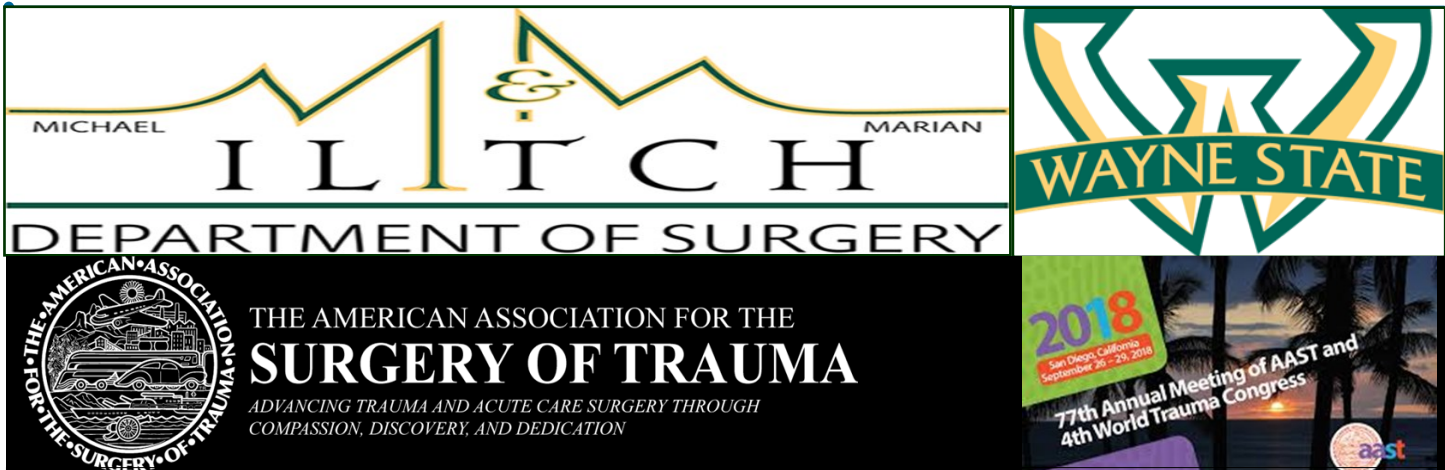
Dr. Dente co-authored a paper by Dr. Caitlin Fitzgerald from Emory University entitled “Changing Outcomes in Abdominal Vascular Injuries Over Time.” These authors showed that the morbidity and mortality from intra-abdominal great vessel injury (aorta, iliac vessels, mesenteric vessels) remains very high in the prior generation; 96 of their 321 patients died. The current survival rate after intra-abdominal arterial injury has improved (69%) compared to the prior generation (46%).

Dr. Dente also co-authored a paper presented by Dr. Dennis Ashley entitled “How Much Green Does It Take to Be Orange? Determining Cost Association with Trauma Center Readiness.” This study demonstrated that the cost to a hospital in order to maintain the state of readiness required for level 1 trauma center verification was over 10 million dollars and almost 5 million dollars for a level 2 trauma center. For each level of trauma center, the costliest component of maintaining readiness was reimbursement to the clinical medical staff.

Dr. David Spain (WSUSOM 1986) co-authored a paper presented by Dr. Lisa Knowlton and co-authors from the Stanford University entitled “Association Between Length-of-Stay and Access to Post-Acute Care: Challenges with Disposition and Impact on Inpatient Costs.” This study pointed out that a large portion of the hospital costs following injury are related to the efficiency of having a patient transferred to a post-acute care setting. Based upon national statistics, these authors demonstrated that the efficiency of obtaining transfer to this type of post-care facility varied with insurance type including medicaid versus private and medicare. More specifically, medicaid patients spent nearly 2.8 extra days awaiting such transfer in comparison to other insurance carriers.

During the annual business meeting of the AAST, *Dr. Spain* was elected as president-elect and will preside over the 2020 meeting in Hawaii.

Dr. David Feliciano, who spent a three-month trauma fellowship with Drs. Lucas and Ledgerwood in the early 1970s, participated on a “pro/con debate” regarding the role of laparotomy versus laparoscopy in a patient with a grade-IV blunt splenic injury. Dr. Feliciano emphasized the importance of ultrasonography (FAST) and diagnostic peritoneal lavage when deciding whether a patient needed to have laparotomy and emphasized that once a decision is made to be within the abdomen in this setting, he strongly supported the use of open laparotomy for definitive care of the ruptured spleen.



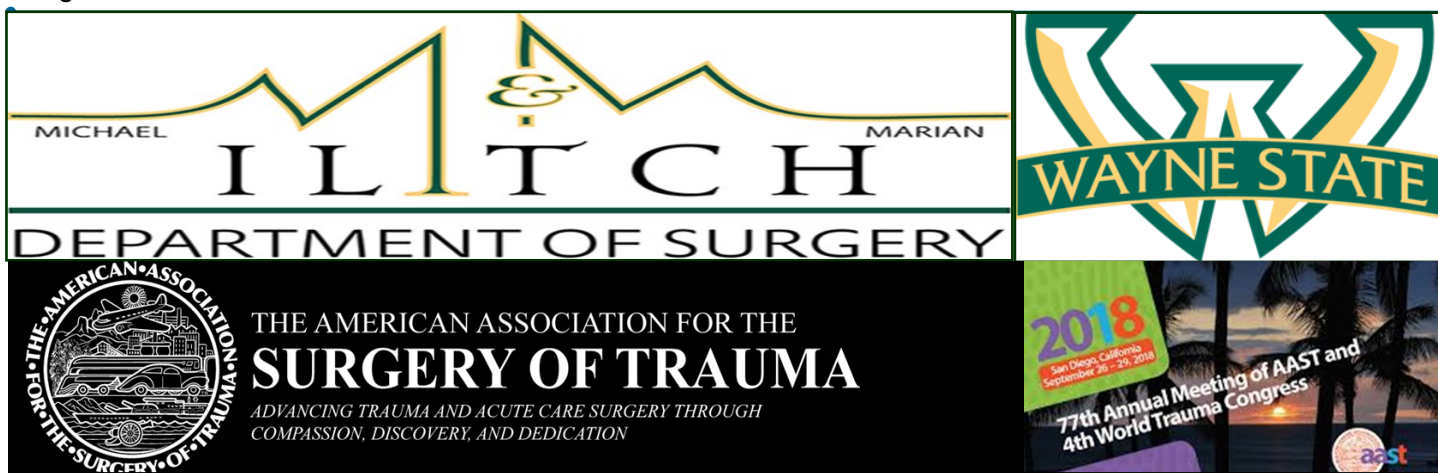

Dr. Andrew Kirkpatrick, who did a one-year trauma fellowship with *Dr. Scott Dulchavsky (WSU/GS 1983/88)*, discussed a paper presented by Dr. Savo Bou Zein Eddine and coworkers from the Medical College of Wisconsin entitled “Observing Pneumothoraces: The 35-Millimeter Rule Is Safe for Both Blunt and Penetrating Chest Trauma.” These authors looked at a very large series of patients with chest injury and identified that those patients who met their criteria for nonoperative management and had a pneumothorax less than 35 mm had a 95% successful treatment with nonoperative management. Factors that predicted failure of nonoperative management included rib fractures and pneumothorax size more than 35 mm for both blunt and penetrating trauma.

Dr. David Feliciano co-authored a paper by Dr. Jamie Coleman and co-authors from the Indiana University School of Medicine entitled “To Sleep, Perchance to Dream: Acute and Chronic Sleep Deprivation in Acute Care Surgeons.” These authors demonstrated that sleep time was significantly higher on post-call day one, decreased significantly on post-call day two, and returned to baseline on post-call day three. These authors suggested that there should be further studies to elucidate the relationship between sleep deprivation and surgical burnout.



Dr. Lawrence Diebel (WSU/GS 1980/86) along with his co-author, Dr. David Liberati from WSU, presented a paper entitled “Red Blood Cell Storage and Adhesion to Vascular Endothelium Under Normal or Stressed Conditions: An In Vitro Microfluidic Study.” These authors used human umbilical vein endothelial cells to examine endothelial injury and glycocalyx shedding with fresh and old RBCs. They demonstrated that the combination of storage and exposure to an ischemic/reperfusion insult was associated with a decrease of the glycocalyx layer of the RBC and the endothelial cells. This reduction of the glycocalyx in both the RBC and the endothelial cell may explain what is known as the “storage lesion” of transfused blood.

Dr. David Feliciano was the invited discussant of a paper by Dr. William Butler, et al from the Scripps Mercy Hospital entitled “Outcomes for Popliteal Artery Injury Rupture After Discharge: A Large-Scale Population-Based Analysis.” These authors pointed out that the short-term results after endoscopic repair versus open repair for popliteal artery injury are similar but that there has been very little followup in order to determine long-term results. They noted that fasciotomy was performed more frequently in the open repair and that the incidence of amputation was comparable for both operative exposures. Arterial embolism or thrombosis was more common after endoscopic repair. Patients who required endovascular and open operative repair were five times more likely to require amputation after discharge and 4.4 times more likely to die after discharge compared to patients who had only an open approach. They concluded that the open repair of popliteal artery injury should continue to be the standard.

Dr. Duane Sands - President of the Pan American Health Organization's 56th Directing Council

The Bahamian Minister of Health, Dr. Duane E. L. Sands (WSUGS/TS 1991/93) has been elected President of the Pan American Health Organization's (PAHO) 56th Directing Council, which convenes the Region's health authorities to discuss and analyze regional health policies and set priorities for technical cooperation and collaboration among countries.

Dr. Sands will preside over the Directing Council, which began on September 27, 2018, where ministers of health from throughout the Region of the Americas will discuss a series of plans to reduce the shortage in health personnel, lower the number of deaths from cervical cancer, and improve the health of women, children, and adolescents.

Dr. Sands thanked the Directing Council for the "distinguished honor of representing the Bahamas as president of the Directing Council," and expressed his hope that "the meeting will be useful in enabling countries to share experiences and gain consensus" in a Region that "has been a driving force for important health achievements in the world." He also highlighted the importance of continuing work towards achieving universal health by 2030.

Dr. Sands is a doctor of cardiology and a vascular surgeon. He worked for more than 20 years as a cardiologist at the Princess Margaret Hospitals in the Bahamas until May 2017, when he was appointed Minister of Health of the Bahamas.

Prior to his role, he was Chairman of the Bahamas Medical Council from 2007 until 2010. He holds diplomas from the American Board of Surgery and the American Board of Thoracic Surgery.

Dr. Sands, who succeeded Dr. Octavio Sanchez Midence, Minister of Health of Honduras, is also a member of the Caribbean Cardiac Society, the Wayne State Surgical Society, and is a Fellow of the American College of Surgeons. He is also a lecturer at the University of West Indies.

The Minister of Public Health of Ecuador, Dr. Veronica Espinosa, and the Minister of Health and Population of Haiti, Dr. Marie Greta Roy Clement, were both elected vice-presidents of the Directing Council.

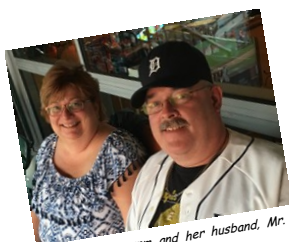

"Dr. Amy Li from the Henry Ford Hospital presented a paper entitled 'Pancreaticoduodenectomy and Placement of Operative Entero-Access: Better or Worse?' His coauthors were Dr. Scott Dulchavsky (WSU/GS 1983/88) and Dr. Chris Steffes (WSUGS 1993). This paper demonstrated that the placement of a feeding tube at the time of pancreaticoduodenectomy does not improve morbidity. They suggested that further studies were warranted to examine whether there is an association between feeding tube placement and recovery of nutritional status after pancreaticoduodenectomy." The editor promises to do better next time!
